 Fertility trends show a decline in Total Fertility Rate.

 Modern contraceptive use among married women has increased.

 Progress has been made in improving maternal and child health, primary education enrollment, and gender equality.



- The Philippines is at a critical juncture in terms of capitalizing on its first demographic dividend.
- The Philippines is facing a severe educational crisis.



- Improved environment for data gathering support for studies are increasing but some issues are more popular than others or get more support or funding.
- Availability of new researches in family planning, reproductive health and population and development.



- The importance of data and evidence is highlighted in the design of programs and projects presented.
- Local efforts such as mobile hospitals and datadriven approaches show promise in improving access and addressing emergencies, especially during disasters.



Challenges

- Persistent disparities in access to health care and education, particularly in underserved areas, hinder equitable progress.
- Gender inequality continues to limit women's participation in the workforce and leadership roles.

 High youth unemployment and skills mismatches affect economic productivity.



Challenges

- Uneven implementation and insufficient indicators challenge sustainable urban development and climate action.
- Rising adolescent pregnancy rates could undermine demographic dividend potential.
- The country lags in maximizing the demographic dividend due to gaps in education, employment, and research on population dynamics.



Challenges

 Geographical barriers, especially for IPs and rural communities, impede access to health services.

 Gender biases and stigmas limit women's autonomy and male involvement in FP.

• Inadequate counseling, provider biases, and structural gaps in community-level mobilization.
