policy As the lead agency in formulation, coordination, and mobilization in various issue of the country, the National Youth Commission shall establish a **forum** for continuing dialogue between the government and youth sector on the proper planning and evaluation of policies, program and activities affecting the youth, convening for the purpose representatives of all youth organizations and institutions, including SKs from barangay, municipal, city, provincial and national levels

- To lobby, promote, and advocate the importance of attaining knowledge in youth mental health, teenage pregnancy, HIV/AIDS, and of course, COVID-19;
- To network and collaborate with other agencies and organizations and collaborate for collective efforts to attain the program's objectives.
- Encourage close coordination between and among Sangguniang Kabataan Officials and the Commission to provide appropriate projects that are beneficial to the current needs of the regions.

100 youth participants from different affiliations attended sessions on various topics including PYDP, Family Planning, HIV/AIDS, Teenage Pregnancy, and Mental Health. BAGIUO CITY (2023)






